AFP-NH hopes that this Scorecard will aid you in your efforts to remain well informed regarding some of the key legislative activity that took place in Concord over this past year and its impact in lowering or increasing barriers to success and enhancing a free and open society. This year certainly saw a change in how the Legislature did business, in response to the pandemic. This led to fewer roll calls than in years past, especially in the State Senate.

AFP-NH does not score every vote in the House or Senate. Rather, the focus of this Scorecard is to consider the most important votes cast in priority issue areas that impact our society, such as taxes and spending, health care, educational opportunity, worker freedom, regulation, free speech, property rights, ending cronyism, and having a criminal justice system that focuses on rehabilitation. This year, the Legislature had the opportunity to vote on important issues in these areas, which are laid out in the vote descriptions.

Within this Scorecard you will find these votes that are essential to removing barriers to opportunity. We hope this helps you see a clear picture of how legislators performed in these important areas.

In addition to information on how your state legislators voted on important pieces of legislation, you will find their contact information included in this Scorecard. AFP-NH hopes you will use it to reach out to your State Senator and State Representatives and encourage them to support policies that advance liberty.

# BILL DESCRIPTIONS

## **INCREASING THE MINIMUM GROSS BUSINESS INCOME REQUIRED FOR FILING A BUSINESS PROFITS TAX RETURN | SB 223**

*Lead Sponsor: Sen. Jeanne Dietsch*

*AFP's Position: Support OTPA*

*Outcome: Passed the Senate 22-2. Died on the table in the House.*

“This bill would raise the filing threshold to file for business profits tax from \$50,000 to \$75,000. This would remove the need for many small businesses to file these tax forms when it is unlikely they would even pay taxes.

## **PROHIBITING COLLECTIVE BARGAINING AGREEMENTS THAT REQUIRE EMPLOYEES TO JOIN OR CONTRIBUTE TO A LABOR UNION | SB 651**

*Lead Sponsor: Sen. Harold French*

*AFP's Position: Oppose ITL*

*Outcome: Killed in the Senate 14-9.*

This bill would make New Hampshire a Right to Work state, ensuring that no worker would be forced to join or pay a union involuntarily.

## **RELATIVE TO NET ENERGY METERING LIMITS FOR CUSTOMER-GENERATORS | SB 159**

*Lead Sponsor: Sen. Jeb Bradley*

*AFP's Position: Oppose Veto Override*

*Outcome: Veto Overridden*

This legislation would expand that amount of electricity that a generator could sell back to the grid at above-market prices from 1 megawatt to 5 megawatts, raising electricity prices for consumers.

## **RELATIVE TO A FAMILY AND MEDICAL LEAVE INSURANCE PROGRAM | HB 712**

*Lead Sponsor: Rep. Mary Jane Wallner*

*AFP's Position: Oppose OTP*

*Outcome: Vetoed by Governor*

This bill would establish a mandatory paid family medical leave entitlement, funded by a 0.5% tax on wages.

## **RELATIVE TO EXPENDITURES FROM THE ENERGY EFFICIENCY FUND | SB 122**

*Lead Sponsor: Sen. Martha Fuller Clark*

*AFP's Position: Oppose OTPA*

*Outcome: Vetoed by Governor*

This bill eliminates the residential rebate for the Regional Greenhouse Gas Initiative, increasing consumers' electricity costs.

## **RELATIVE TO THE STATE MINIMUM HOURLY RATE | HB 731**

*Lead Sponsor: Rep. Kristina Schultz*

*AFP's Position: Oppose OTPA*

*Outcome: Vetoed by Governor*

This bill would raise the minimum wage to \$12/hour, making it harder for less experienced workers to find employment.

# BILL DESCRIPTIONS

## RELATIVE TO ALTERNATIVE LEARNING CREDIT RULES OF THE STATE BOARD OF EDUCATION | HB 1454

*Lead Sponsor: Rep. Linda Tanner*

*AFP's Position: Oppose OTPA*

*Outcome: Vetoed by Governor*

This bill would have stifled innovation in education and stripped away the alternative learning paths available through the implementation of the Learn Everywhere program.

## RELATIVE TO THE MINIMUM ELECTRIC RENEWABLE PORTFOLIO STANDARDS | SB 124

*Lead Sponsor: Sen. Martha Fuller Clark*

*AFP's Position: Oppose OTPA*

*Outcome: Vetoed by Governor*

This bill would increase the regulatory demands on above market electricity supplies, which would increase energy costs for New Hampshire residents and employers.





# BILL DESCRIPTIONS

## RELATIVE TO THE REGULATION OF ART THERAPISTS | HB 546

*Lead Sponsor: Rep. Peter Schmidt*

*AFP's Position: Oppose OTPA*

*Outcome: Passed the House 218-144. Bill died on the table in the Senate.*

This bill adds the licensure and regulation of art therapists under the board of mental health practice, making it more difficult for Granite Staters to enter the field.

## RELATIVE TO THE PRIVACY OF CERTAIN INFORMATION CONCERNING PUBLIC EMPLOYEES | SB 19

*Lead Sponsor: Sen. Kevin Cavanaugh*

*AFP's Position: Oppose OTPA*

*Outcome: Vetoed by Governor*

The legislation would undercut the privacy rights of public sector workers by delivering their personal contact information to the labor union for their bargaining unit.

## RELATIVE TO POINT OF SALE BAGS | HB 559

*Lead Sponsor: Rep. Judith Spang*

*AFP's Position: Oppose OTPA*

*Outcome: Passed the House 205-158. Bill died on the table in the Senate.*

This bill would create a 10-cent fee for paper and plastic bags and would mandate the type of bags that could be sold by retailers. This would drive up the costs for consumers.

## RELATIVE TO THE USE OF FUNDS IN THE DRUG FORFEITURE FUND | HB 1563

*Lead Sponsor: Rep. James Spillane*

*AFP's Position: Support OTP*

*Outcome: Passed out of first House committee 329-21. Failed to meet deadline for 2nd committee.*

This bill would change the incentive structure in policing by directing a portion of the Drug Forfeiture Fund towards treatment for addicts.



# BILL DESCRIPTIONS

## **ESTABLISHING GREENHOUSE GAS EMISSION REDUCTION GOALS FOR THE STATE AND ESTABLISHING A CLIMATE ACTION PLAN | HB 1664**

*Lead Sponsor: Rep. Craig Thompson*

*AFP's Position: Oppose OTPA*

*Outcome: Passed the House 197-123. Bill died on the table in the Senate.*

This bill would shift direction of state environmental policy from the legislature to unelected state officials. Additionally, it would drive up costs for state purchases.

## **RELATIVE TO THE HOME CULTIVATION OF CANNABIS PLANTS AND THE POSSESSION OF CERTAIN CANNABIS-INFUSED PRODUCTS | HB 1648**

*Lead Sponsor: Rep. Carol McGuire*

*AFP's Position: Support OTPA*

*Outcome: Passed the House 236-112. Bill died on the table in the Senate.*

This bill removes penalties associated with personal possession, use, and home cultivation of cannabis.

## **RELATIVE TO ELECTIONS IN COLLECTIVE BARGAINING | HB 1554**

*Sponsor: Rep. Hershel Nunez*

*AFP's Position: Oppose ITL*

*Outcome: Bill was killed 211-136.*

This bill would ensure that public sector workers would have the opportunity to vote on whether to keep their existing union in place when a majority of current workers in that bargaining unit did not have a chance to choose their representation.

## **RELATIVE TO REPORTS ON EDUCATION TAX CREDIT SCHOLARSHIPS | HB 1423**

*Lead Sponsor: Rep. Linda Tanner*

*AFP's Position: Oppose OTP*

*Outcome: Passed the House 192-135. Bill died on the table in the Senate.*

This bill would add to the requirements for scholarship organization reports to the department of revenue administration creating an additional burden for homeschool families.

## **REQUIRING THE ADOPTION OF INNOVATIVE VEHICLE EMISSIONS STANDARDS PURSUANT TO SECTION 177 OF THE FEDERAL CLEAN AIR ACT | HB 1444**

*Lead Sponsor: Rep. Rebecca McWilliams*

*AFP's Position: Oppose OTPA*

*Outcome: Passed the House 179-109. Bill died on the table in the Senate.*

This bill would require vehicles sold in New Hampshire to comply with California emission standards, driving up the cost to purchase a vehicle.
