

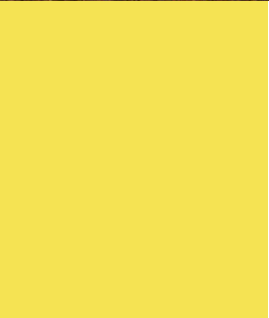

# BILL DESCRIPTIONS

## **ALLOWS DRIVERS TESTS TO BE GIVEN IN SPANISH | SB 70**

*Sponsor: Senator VJ Smith, Rep Jessica Olson*

*AFP's Position: Support*

*Outcome: Passed/Enacted*

This bill makes driver's license written exams available in Spanish, thereby reducing a barrier for Spanish speaking residents to get a driver's license and enhancing their access to the job market.

## **REQUIRES A PUBLIC VOTE FOR SCHOOL BOND ISSUES | HB 1263**

*Sponsor: Rep Tim Goodwin, Senator Jim Stalzer*

*AFP's Position: Support*

*Outcome: Passed House/Failed Senate*

This bill restricts bond issue election dates to the primary and/or general election dates each year. By doing so, it ensures higher governmental transparency on important spending decisions. Individuals will expect that bond issues could be on the ballot and will not have the opportunity to miss a newspaper or other notification to vote in a special election on a different day.

## **ELIMINATES HIGHER EDUCATION UNION COLLECTIVE BARGAINING | SB 147**

*Sponsor: Senator Kris Langer, Rep Jon Hansen*

*AFP's Position: Support*

*Outcome: Passed/Enacted*

This bill eliminates mandatory collective bargaining with government unions in higher education employees which leads to more responsible higher education decisions and more choice for SD teaching staff.

## **ALLOWS PEOPLE TO DO ELECTRICAL WORK ON THEIR OWN PROPERTY WITHOUT A LICENSE | HB 1070**

*Sponsor: Rep Herman Otten, Senator Ernie Otten*

*AFP's Position: Support*

*Outcome: Passed/Enacted*

This bill eliminates the need to have a license to do electrical work on your own home, thus eliminating a occupational licensing barrier.

## **EXPANDS THE SCOPE OF PRACTICE FOR CNRAS TO INCREASE ACCESS TO HEALTH CARE | SB 50**

*Sponsor: Senator Deb Soholt, Rep Jean Hunhoff*

*AFP's Position: Support*

*Outcome: Passed/Enacted*

This bill expands the scope of practice for Certified Nurse Anesthetists, thereby increasing access to health care, especially in the rural areas of our state.



### **CREATES A LIMITED CHARTER SCHOOL PILOT PROGRAM TARGETED FOR NATIVE AMERICANS | SB 66**

*Sponsor: Senator Troy Heinert, Rep Peri Purier*

*AFP's Position: Support*

*Outcome: Passed Senate/Failed House*

This bill would have created and funded Oceti Sakowin community-based schools, expanding educational options for many Native American families in our state. All students should have access to the educational environment that best fits their unique talents and needs. Unfortunately, too many students in our state, particularly Native American students, do not have access to an educational environment that that can help them discover, develop, and apply their talents. This bill would have been a step in the right direction in order to provide families with more educational options.

### **REQUIRES A CONVICTION BEFORE THE PERMANENT SEIZURE OF PROPERTY BY LAW ENFORCEMENT | SB 172**

*Sponsor: Senator Art Rusch, Rep Jessica Olson*

*AFP's Position: Support*

*Outcome: Failed Senate*

This bill better protects South Dakotans' property rights by requiring a criminal conviction before law enforcement can permanently keep seized property. The bill also improves transparency by adding important reporting requirements.

### **ALLOWS PEOPLE TO DO PLUMBING WORK ON THEIR OWN PROPERTY WITHOUT A LICENSE | HB 1079**

*Sponsor: Rep. Herman Otten, Sen. Ernie Otten*

*AFP's Position: Support*

*Outcome: Signed by Governor*

The South Dakota Plumbing Commission recently decided that property owners were not eligible to perform plumbing work on their properties without first acquiring a plumbing license. This bill fixed that interpretation and removed unnecessary red tape that required property owners to have an occupational license to perform plumbing work on their own properties.

### **ELIMINATES RESTRICTIONS OF FREE SPEECH ON SOUTH DAKOTA COLLEGES AND UNIVERSITIES | HB 1087**

*Sponsor: Rep. Sue Peterson, Sen. Jim Stalzer*

*AFP's Position: Support*

*Outcome: Signed by Governor*

Higher education provides a unique forum for students to freely and productively engage with a range of ideas—education that enables a thoughtful and diverse society. This bill protects these unique environments on our college campuses and protects the free speech rights of students in South Dakota.

# BILL DESCRIPTIONS

## **CHANGES THE SALES TAX REDUCTION LANGUAGE CURRENTLY IN LAW BY CREATING AN SIMPLIER AUTOMATIC PROCESS | HB 1265**

*Sponsor: House Whip Chris Karr*

*AFP's Position: Support*

In a previous legislative session, South Dakota lawmakers raised the state's sales tax from 4% to 4.5% percent, with a deal in place to reduce the rate by 0.1% for every \$20 million received in online sales tax revenue. This bill would have clarified that requirement by including an automatic trigger if government revenue grew by a specified amount, ensuring that there will be automatic sales tax relief for South Dakotans.

## **STREAMLINES THE TAX CREDIT SCHOLARSHIP PROGRAM TO REMOVE SOME OBSTACLES THAT WERE PREVENTING PRIVATE DONATIONS | SB 96**

*Sponsor: Sen. Lee Schoenbeck, House Whip Jon Hansen*

*AFP's Position: Support*

*Outcome: Signed by Governor*

Educational freedom allows students to get the education that best meets their needs. This bill expands the South Dakota Partners in Education (PIE) tax credit scholarship program to allow the credit to apply to 100% of the contribution and allow for quarterly reporting. This helps ensure students, regardless of income or ZIP code, have access to education that helps them learn and thrive.

## **CREATES AN OCCUPATIONAL LICENSE FOR ACUPUNCTURE PRACTITIONERS | HB 1136**

*Sponsor: Rep Tamara St John, Senator Red Dawn Foster*

*AFP's Position: Oppose*

*Outcome: Failed on House Floor*

This bill creates an unnecessary board and licensure requirement for acupuncture practitioner. Private markets are a much better regulator of this sort of thing.

## **ADDS ADDITIONAL COUNTY TAX AUTHORITY TO BUILD JAILS AND OTHER COUNTY STRUCTURES | HB 1099**

*Sponsor: Rep Nancy York, Senator Al Novstrup*

*AFP's Position: Oppose*

*Outcome: Failed on the House Floor*

This bill creates new sales tax authority for counties. It would be better to reduce costs by criminal justice reform as opposed to raising taxes.

## **REVERSES CURRENT CRIMINAL JUSTICE REFORMS IN LAW BY TIGHTENING PROBATION REFORMS | SB 6**

*Sponsor: Attorney General Ravensberg*

*AFP's Position: Oppose*

*Outcome: Passed Senate/Failed House*

This bill tightens the conditions under which presumptive probation can be extended. It is a backward step in the cause of criminal justice reform and would result in even more taxpayer dollars being spent on jails and prisons.





### **REVERSES CURRENT CRIMINAL JUSTICE REFORMS IN LAW BY RESTRICTING PROBATION REFORMS | SB 19**

*Sponsor: Attorney General Ravensberg*

*AFP's Position: Oppose*

*Outcome: Died in Senate*

Presumptive probation allows lower risk individuals guilty of more minor offenses the opportunity to pay their debt to society through community-based sanctions, while allowing judges to still put more dangerous individuals behind bars. Not everybody who makes a mistake needs to be incarcerated to rehabilitate. SB 19 would have repealed the presumption of probation for lower risk individuals, and put many more people unnecessarily behind bars.

### **CHANGES THE SALES TAX REDUCTION LANGUAGE CURRENTLY IN LAW BY ASSIGNING THE AUTHORITY TO REDUCE THE RATE TO THE JOINT APPROPRIATIONS COMMITTEE | SB 86**

*Sponsor: Sen. Jeffrey "Jeff" Partridge, Rep. David Anderson*

*AFP's Position: Oppose*

South Dakotans face large enough tax burdens. This bill would not guarantee a tax break for South Dakotans following the new revenue stream which is a product of the Wayfair Supreme Court case. Previous legislation regarding the increased sales tax included a deal that would reduce the tax by 0.1% for every \$20 million in online sales tax revenue.

### **ADDS ADDITIONAL TAX AUTHORITY TO BUILD JAILS AND OTHER CRIMINAL JUSTICE RELATED STRUCTURES | SB 65**

*Sponsor: Whip Al Novstrup, Rep. Nancy York*

*AFP's Position: Oppose*

*Outcome: Died in Senate*

This legislation would have given new authority to raise taxes to build more jails, which frequently drive increased incarceration, costing taxpayers even more and undermining more proportionate criminal justice approaches.
