### **BILL DESCRIPTIONS**

# HB 2660 | OCCUPATIONAL REGULATION; PRIOR CONVICTION; APPLICABILITY

Rep. John Allen | 2019 Session

HB 2660 gives formerly incarcerated individuals a better opportunity for a second chance at rejoining their communities by ensuring they cannot be denied an occupational license for a crime committed more than seven years prior, with certain exceptions in the interest of public safety.

#### HB 2569 | OCCUPATIONAL LICENSING; RECIPROCITY

Rep. Warren Petersen | 2019 Session

HB 2569 removes barriers for new Arizonans by recognizing virtually all out-of-state occupational licenses. This makes it easier for Arizonans to provide for their families, pursue their chosen profession when relocated, and increases the abundance of various skilled workers.

#### HB 2463 | OCCUPATIONAL REGULATIONS; LICENSES; COMMUNICATIONS; NOTICE

Rep. Warren Petersen | 2019 Session

This proposal requires agencies to inform those who apply for occupational licenses of their right to petition the agency to repeal, modify, or bring an action in a court of general jurisdiction to challenge a regulation that may be unnecessary or burdensome.

#### HB 2636 | MOBILE FOOD VENDORS; MUNICIPALITIES

Rep. Kevin Payne | 2019 Session

This proposal allows mobile food vendors (such as food trucks) to operate on private property under certain conditions: they obtain permission from the property owner, do not serve food to the general public, and they follow other specific restrictions set by local municipalities. If enacted, this legislation ensures more flexibility for mobile food vendors.

#### HB 2182 | PERMIT; LICENSE; DENIALS; AGENCY HEARING

Rep. Travis Grantham | 2019 Session

HB 2182 requires local governments or regulatory agencies to justify in a court of law the requirement of a permit or license for any constitutionally protected activity. This proposal protects the fundamental rights of all Arizonans and cuts down on any red tape that would limit those rights.

### HB 2055 | JUVENILE COURT; JURISDICTION; UNDESIGNATED FELONY

Rep. John Allen | 2019 Session

This legislation directs the juvenile court system to retain jurisdiction after an individual's 18th birthday to decide whether to classify an undesignated felony as a misdemeanor or felony as well as to determine if they are eligible for their charges to be set aside.



#### HB 2311 | INCORRECT ARREST; RECORD CLEARANCE

Rep. Cesar Chavez | 2019 Session

This legislation requires any person wrongfully arrested, indicted, or charged with a crime, to be notified by a law enforcement officer, opposing party, or the court of their right to file a petition to clear that part of their record.

#### HB 2231 | NONHEALTH PROFESSIONS; OCCUPATIONS; REGULATIONS

Rep. Anthony Kern | 2019 Session

This proposal promotes future legislative committees to have a substantive discussion of alternatives to occupational licensing during the sunrise and sunset review processes for non-health agencies. The goal would be to limit burdensome red tape that limits individuals' ability to earn a living through their chosen profession.

### HB 2062 | JUVENILE DISPOSITION; PROBATION TERMS; NOTICE

Rep. John Allen | 2019 Session

After a risk assessment is performed, the juvenile court may increase probation requirements instead of charging a juvenile with a repetitive felony offense through HB 2062.

# SB 1109 | SHORT-TERM LIMITED DURATION INSURANCE; NOTICE

Sen. David Livingston | 2019 Session

Allows short term limited duration (12-36 months) insurance to be purchased as an alternative to current health insurance options.

### SB 1033 | PROPERTY TAX STATEMENTS; MORTGAGED PROPERTY

Sen. Vince Leach | 2019 Session

SB 1033 changes the requirement for county treasurers to mail a statement of property taxes due on a mortgaged property to the mortgagor rather than only doing so when requested.

# **BILL DESCRIPTIONS**

#### SB 1001 | HIGHWAY SAFETY FEE; REPEAL; VLT

Rep. Michelle Udall | 2019 Session

The Senate companion bill to HB 2442, SB 1001 repeals the highway safety fee previously raised by the Arizona Director of the Department of Transportation. This would save Arizonans and businesses money.

#### SB 1143 | CONFORMITY; INTERNAL REVENUE CODE; RATES

Sen. J.D. Mesnard | 2019 Session

Capitalizing on 2017's historic tax relief, this proposal lowers income taxes for all tax rates to match the savings of the federal tax reform.

#### SB 1310 | EARNED RELEASE CREDITS; DRUG OFFENSES

Sen. Eddie Farnsworth | 2019 Session

SB 1310 expands Arizona's early release credit program for formerly incarcerated individuals with low level and non-violent drug-related sentences.

#### SB 1334 |SENTENCING; REPETITIVE OFFENDERS

Sen. J.D. Mesnard | 2019 Session

This proposal prohibits individuals from being sentenced as a repeat offender if they have not appeared before a judge and convicted of a previous felony.

#### **SB 1085 | ASSOCIATION HEALTH PLANS**

Sen. Kate Brophy McGee | 2019 Session

This proposal would allow associations to pool health care benefits and plans to share with small employer members.

#### HB 2361 | SENTENCING; REPETITIVE OFFENDERS

Rep. Ben Toma | 2019 Session

This bill prohibits individuals from being sentenced as repeat offenders if they have not previously appeared before a judge and convicted of a prior felony.

#### HB 2724 | EGG-LAYING HENS; CONFINEMENT; REGULATION

Rep. Timothy "Tim" Dunn | 2020 Session

This misguided legislation would add new regulations on commercial farmers with egg-laying hen enclosures and establish civil penalties for any potential violations of these newly implemented barriers.

#### HB 2808 | PRISONERS; RELEASE CREDITS

Rep. Walter "Walt" Blackman | 2020 Session

HB 2808 expands early release credit programs for formerly incarcerated individuals who have completed a drug treatment program or major improvement program.

#### HB 2752 | INDIVIDUAL INCOME TAX; RATE ADJUSTMENT

AZ Rep. Bret Roberts | 2020 Session

The House companion bill of SB 1489, HB 2752 protects Arizona taxpayers from an ever-increasing income tax burden by providing guaranteed tax relief in times of economic growth.

#### HB 2442 | HIGHWAY SAFETY FEE REPEAL

Rep. Leo Biasiucci | 2020 Session

HB 2442 repeals the highway safety fee previously raised by the Arizona Director of the Department of Transportation. This would save Arizonans and businesses money.

### HB 2402 | CRIMINAL CONVICTION; SET ASIDE; APPLICABILITY

Rep. Bret Roberts | 2020 Session

HB 2402 expands opportunities for formerly incarcerated individuals to have a fresh start by allowing courts to issue a "certificate of second chance" that removes criminal history barriers to occupational licensing and protects employers from liability.

#### HB 2036 | FENTANYL; HEROIN; CARFENTANIL; MANDATORY SENTENCING

Rep. Steve Pierce | 2020 Session

This legislation would double down on a failed and ineffective approach to combatting drug abuse by



g increasing mandatory minimum felony charges for those who possess, use, sell, manufacture, or transport heroin and/or fentanyl.

HB 2899 | FUEL; ELECTRIC CARS; HYBRIDS; TAXES Rep. Noel Campbell | 2020 Session

This misguided proposal would have increased Arizona's gasoline tax by 18 cents per gallon by 2023, providing an exorbitant burden on Arizona families, small businesses, and various industries.

### **BILL DESCRIPTIONS**

#### HB 2817 | AIRPORT FEES PROHIBITED; RIDE SHARING

Rep. Travis Grantham | 2020 Session

This proposal prohibits public airport operators and public bodies from imposing a tax, fee, or assessment of any kind on transportation network companies for operating at the public airport. This lowers any additional tax burden Arizonans may face when traveling.

#### HB 2686 | BUILDING PERMITS; UTILITIES; RESTRICTIONS; PROHIBITIONS

Rep. Russell "Rusty" Bowers | 2020 Session

This legislation prohibits local governments from denying a permit to a utility provider or restricting services of a utility provider that is capable and authorized to provide a utility service. This proposal would increase both competition and availability of resources to more Arizonans.

#### SB 1171 | CRIMINAL JUSTICE CASE INFORMATION; REPORTING

Sen. J.D. Mesnard | 2020 Session

SB 1171 would have required the Arizona Criminal Justice Commission to conduct a comprehensive survey of data from all of the state's justice agencies to provide a clearer picture of our criminal justice system and its outcomes. Better data reporting would have allowed Arizona to craft criminal justice policies based on the evidence of what improves safety while supporting communities and protecting taxpayers.

### SB 1142 | NONHEALTH PROFESSIONS; OCCUPATIONS; REGULATIONS

Sen. Tyler Pace | 2020 Session

This proposal promotes future legislative committees to have a substantive discussion of alternatives to occupational licensing during the sunrise and sunset review processes for non-health agencies. Traditionally, burdensome red tape on entering a given profession disproportionately impacts low income individuals.

#### SB 1556 | CIVIL ASSET FORFEITURE; CONVICTION; PROCEDURES

Sen. Eddie Farnsworth | 2020 Session

This proposal reforms Arizona's civil asset forfeiture statues, requiring the state to obtain a conviction before forfeiture proceedings may take place with important exceptions related to public safety and the protection of private property rights.

#### SB 1274 | PROFESSIONAL REGULATORY BOARDS; COMPOSITION

Sen. Michelle Ugenti-Rita | 2020 Session

SB 1274 modifies the membership of Arizona's State Board of Technical Registration, the Board of Barbers, the Board of Cosmetology, the State Board of Funeral Directors and Embalmers, and the Board of Massage Therapy to include more members of the public.



HB 2413 | JUVENILE COURT; DISPOSITIONS Rep. John Allen | 2020 Session

This proposal allows the juvenile court to retain jurisdiction until a juvenile's 19th birthday to modify or waive fine and fee obligations except for victim restitution.

### SB 1224 | EMPOWERMENT SCHOLARSHIPS; QUALIFIED SCHOOLS; RESERVATIONS

Sen. Sylvia Allen | 2020 Session

This proposal makes many reforms to Arizona's Empowerment Scholarship Accounts that increase access and educational opportunity for students. This includes increasing access to ESAs for students who live two miles outside of our state borders, specifically on Native American reservations.

### SB 1489 | INDIVIDUAL INCOME TAX; RATE ADJUSTMENT

Sen. J.D. Mesnard | 2020 Session

d SB 1489 protects Arizona taxpayers from an everincreasing income tax burden by providing guaranteed tax relief in times of economic growth.

### SB 1529 | HEALTH CARE MINISTRIES; EXEMPTION; DEFINITION

Sen. David Livingston | 2020 Session

Following the lead of previously repealed restrictive regulations, this proposal would allow health care sharing ministries founded after December 31, 1999 to follow the same guidelines as those founded prior.
