CRIMINAL JUSTICE

HB 1111 | REVISE CERTAIN PROVISIONS REGARDING INSPECTIONS AND SEIZURES BY, AND FORFEITURES INVOLVING, THE DEPARTMENT OF GAME, FISH AND PARKS

Sponsor: Judiciary
AFP Position: Support
Result: Enacted

HB 1111 revises provisions regarding seizures and forfeitures to ensure the Game, Fish, and Parks Department cannot seize property with a court order.

SB 174 | REVISE PROVISIONS RELATED TO THE AUTOMATIC REMOVAL OF CERTAIN CHARGES OR CONVICTIONS FROM A DEFENDANT’S PUBLIC RECORD

Sponsors: Rep. Tim Reed and Sen. David Wheeler
AFP Position: Support
Result: Enacted

SB 174 requires the removal of records related to petty offenses, ordinance violations, or Class 2 misdemeanors from public records after five years if the person has remained crime free and fulfilled the conditions of their punishment.

SB 164 | PROVIDE FOR A FORMAL PROCESS CRIMINAL FORFEITURE

Sponsors: Sen. Timothy Johns and Rep. Bethany Soye
AFP Position: Support
Result: Enacted

SB 164 reduces the use of civil asset forfeiture when the crime suspected is drug possession.

SB 143 | REVISE THE PENALTY FOR THE INGESTION OF CERTAIN CONTROLLED SUBSTANCES

Sponsors: Sen. Michael Rohl and Rep. Aaron Aylward
AFP Position: Support
Result: Introduced and Defeated

SB 143 would have reclassified having drugs or other controlled substances in your bloodstream from a felony to a misdemeanor for the first and second violation.

FREE EXPRESSION

SB 103 | PROVIDE FOR THE CONFIDENTIALITY OF PERSONAL INFORMATION OF PERSONS AFFILIATED WITH NONPROFIT CORPORATIONS.

Sponsor: Sen. Casey Crabtree and Rep. Kirk Chaffee
AFP Position: Support
Result: Enacted

SB 103 ensures the confidentiality of personal information for persons affiliated with nonprofit organizations by barring, in most cases, public agencies from demanding or releasing such information.



HB 1079 | LIMIT CERTAIN ACTIONS THAT MAY BE TAKEN BY THE EXECUTIVE BRANCH RELATIVE TO NONPROFIT CORPORATIONS AND CHARITABLE TRUSTS

Sponsor: Judiciary
AFP Position: Support
Result: Enacted

HB 1079 bars, in most cases, state agencies from requiring any annual filing or reporting of a nonprofit corporation or charitable trust that is more restrictive than required by state or federal law.

HEALTH CARE

HB 1065 | ADOPT THE EMERGENCY MEDICAL PERSONNEL LICENSURE INTERSTATE COMPACT

Sponsor: Sen. V. J. Smith and Rep. Rhonda Milstead
AFP Position: AFP-SD and our activists believe this bill is improves access to health care which we all agree is important to South Dakotans.
Result: Enacted

HB 1065 adopts the Interstate Emergency Medical Service Personnel Licensing Compact, to facilitate the movement of EMS personnel across state lines.

HB 1077 | PROVIDE FOR LICENSURE BY ENDORSEMENT FOR CERTAIN LICENSED PROFESSIONALS AND OCCUPATIONS

Sponsors: State Affairs

Result: Enacted

HB 1077 recognizes licensed health care providers across state lines.

HB 1131 | AUTHORIZE PRIMARY CARE AGREEMENTS

Sponsors: Sen. Larry Zikmund and Rep. Tamara St. John

AFP Position: AFP-SD and our activists believe that health care needs to be reimagined and that creative, proven concepts like direct primary care should be encouraged in South Dakota.

Result: Enacted

HB 1131 removes regulatory restrictions on direct primary care agreements.

SB 96 | REVISE THE PROVISIONS OF PARENTAL CHOICE REGARDING COMPULSORY SCHOOL ATTENDANCE AND MATTERS ANCILLARY THERETO

Sponsors: Health and Human Services

AFP Position: AFP-SD and our activists believe that health care needs to be reimagined and that increasing access by means such as telehealth technologies is a step in the right direction toward solving some of our health care problems.

Result: Enacted

SB 96 expands the use of telehealth by allowing the patient-provider relationship to be established via technology.

SB 87| EXEMPT HEALTH BENEFIT PLANS SPONSORED BY NONPROFIT AGRICULTURAL ORGANIZATIONS FROM INSURANCE REGULATION

Sponsors: Sen. Gary Cammack and Rep. Rocky Blare

AFP Position: AFP-SD and our activists understand the need to reimagine health care. Some of the principles that we should use to work toward improving health care in South Dakota are improving access, increasing affordability, and enhancing transparency in pricing. This bill focuses on the affordability aspect of this vision. It provides an affordable health care option for our agricultural community.

Result: Enacted

SB 87 exempts health benefit plans sponsored by nonprofit agricultural organizations from insurance regulation.

HB 1004 | REPEAL THE REGISTRATION REQUIREMENT FOR MEDICAL ASSISTANTS

Sponsors: Health and Human Services

AFP Position: Support

Result: Enacted

HB 1004 repeals the registration requirement for medical assistants.

HB 1263 | PROVIDE PRICE TRANSPARENCY FOR HEALTH CARE COSTS

Sponsors: Health and Human Services

AFP Position: Support

Result: Enacted

HB 1263 increases transparency for health care costs.



HB 1154 | PROHIBIT EMPLOYMENT CONTRACTS RESTRICTING COMPETITIVE HEALTH CARE PRACTICES

Sponsors: Sen. R. Blake Curd and Rep. Fred Deutsch

AFP Position: AFP-SD and our activists believe that health care needs to be reimagined and that eliminating competition restrictions like non-compete clauses is a step in the right direction toward solving some of our health care problems.

Result: Enacted

HB 1154 eliminates the use of non-compete clauses in health care employment contracts.

K-12 EDUCATION

SB 175 | REMOVE CERTAIN ELIGIBILITY REQUIREMENTS FOR THE PARTNERS IN EDUCATION TAX CREDIT PROGRAM

Sponsors: Sen. Jim Stalzer and Rep. Jon Hansen

AFP Position: AFP-SD and our activists understand the importance of all children throughout our state having access to educational opportunity that makes sense for them. Part of helping South Dakota's children realize their full potential sometimes means helping families afford a private education that would be outside their financial ability without scholarship access. It is really a win-win since the state actually saves money by allowing private support of this program. It's a win for the students as well as the taxpayer. This bill expands who is eligible for the scholarship.

Result: Enacted

SB 175 expands the eligibility for scholarships in the Partners in Education tax credit program.

SB 177 | REVISE THE PROVISIONS OF PARENTAL CHOICE REGARDING COMPULSORY SCHOOL ATTENDANCE AND MATTERS ANCILLARY THERETO

Sponsors: Sen. Wayne Steinhauer and Rep. Rebecca Reime

AFP Position: Support

Result: Enacted

SB 177 asserts and clarifies the parental right to choose where and how to educate their children, eliminate a wasteful testing requirement, and promote inclusion in activities sanctioned by the South Dakota High School Activities Association.

SB 46 | ALLOW FOR THE CONSIDERATION OF CERTAIN INSTRUCTION TO COUNT TOWARDS THE MINIMUM NUMBER OF HOURS REQUIRED IN A SCHOOL TERM DURING A DECLARED STATE OF EMERGENCY

Sponsors: Education

AFP Position: Support

Result: Enacted

SB 46 allows for the consideration of certain instruction to count toward the minimum number of hours required in a school term during a declared state of emergency.

SB 68 | PROVIDE FOR THE CREATION AND FUNDING OF OCETI SAKOWIN COMMUNITY-BASED SCHOOLS

Sponsors: Sen. Troy Heinert and Rep. Peri Pourier

AFP Position: Support

Result: Passed First Chamber

SB 68 would have created a vehicle for the creation of Oceti Sakowin community-based schools.

REGULATIONS

SB 55 | AUTHORIZE CERTAIN INNOVATIVE INSURANCE PRODUCTS AND SERVICES THROUGH INSURANCE INNOVATION WAIVERS

Sponsors: Commerce and Energy

AFP Position: Support

Result: Enacted

SB 55 streamlines the regulatory environment for new and innovative business services and contracts.

TAX AND SPENDING

HJR 5003 | PROPOSING AND SUBMITTING TO THE VOTERS OF THE NEXT PRIMARY ELECTION A NEW SECTION TO ARTICLE XI OF THE CONSTITUTION OF THE STATE OF SOUTH DAKOTA

Sponsors: Sen. Lee Schoenbeck and Rep. Jon Hansen

AFP Position: Support

Result: Referred to state-wide ballot

HJR 5003 requires any future proposed initiative or constitutional amendment that increases taxes or spends more than \$50 million in its first five fiscal years to receive 60 percent of the vote for approval.

CORONAVIRUS

HB 1046 | LIMIT LIABILITY FOR CERTAIN EXPOSURES TO COVID-19

Sponsor: Sen. Casey Crabtree and Rep. David Anderson

AFP Position: Support

Result: Enacted

HB 1046 provides liability protections for certain exposures to COVID-19.
