

SCORING METHODOLOGY

The South Carolina scorecard tracks bills from the committee process to floor votes. While some of these bills had legislation filed in both the House and Senate, others were filed in one chamber only. Each of Americans for Prosperity-South Carolina's (AFP-SC) legislative priorities is included on this scorecard, as well as additional issues we explicitly supported or opposed during the 2021 regular legislative session. Summaries for all bills and issues and their results during the legislative process are included in the scorecard. One point has been awarded for each vote cast in support of an issue that removes barriers for society or against

an issue that creates new barriers. Each vote carries the same weight. We also awarded one point for prime sponsorship of a priority bill we supported, and deducted a point for sponsorship of a bill we opposed.

Americans for Prosperity-South Carolina hopes that this scorecard will aid your efforts to remain well-informed regarding some of the key legislative activity that took place in Columbia this year.

AFP-South Carolina does not score every vote in the House or Senate. Rather, the focus of this scorecard is to consider the most important votes cast on priority issues that affect our society, such as taxes and spending, health care, educational opportunity, worker freedom, regulation, free speech, property rights, ending cronyism, and having a criminal justice system that focuses on rehabilitation. This year, the legislature had the opportunity to vote on important issues in these areas, which are laid out in the vote descriptions.

Your voice helps us tackle our state's biggest problems and ensures we enact public policies that cement our state as the best place to live, work, and raise a family. Through continuous grassroots engagement driven by people like you, our organization has emerged as one of the most influential in the state. We are partnering with diverse coalitions and finding common ground with principled lawmakers of both parties to meaningfully advance policies proven to help every person rise.

Our top issues of fully repealing certificate-of-need regulations and abolishing civil asset forfeiture were unfortunately stalled in the legislative process. These critical reforms will continue to be top priorities for us as we head into 2022, including accountability campaigns this fall.

AFP-South Carolina hopes you will use this scorecard as a tool to hold lawmakers accountable for their positions and encourage them to support policies that advance freedom and opportunity for every South Carolinian.

BILL DESCRIPTIONS

SJR 147 | LIABILITY SAFE HARBOR ACT

AFP Position: Support Result: Signed by governor

Americans from all walks of life have come together to fight the COVID-19 pandemic. Frontline health care workers, businesses of all sizes, schools, faith-based organizations, and nonprofits have stepped up to provide care and relief to the communities they serve. This bill provides liability protections for a limited time to health care providers and businesses that follow public health guidance in response to the coronavirus public health emergency.

SJR 491 | ECONOMIC DEVELOPMENT BONDS

AFP Position: Oppose Result: Passed Senate 45-1; In House Ways and Means Committee

Americans for Prosperity remains committed to standing up for taxpayers and against corporate handouts. As such, one of our priorities is decreasing and eliminating cronyism, whether it be subsidies, tax credits, or regulatory favoritism toward an industry. This bill would authorize the issuance of state economic development bonds using hundreds of millions of taxpayer dollars.

HB 3050 | LAW ENFORCEMENT OFFICERS CERTIFICATION

AFP Position: Support Result: Passed House: 100-13; In Senate Judiciary Committee

Our hardworking law enforcement officers deserve the necessary training and resources to help them respond safely and effectively to the complicated situations they face every day. This bill would: add a duty to intervene when one officer sees another engaging in excessive use of force; require law enforcement agencies to work with the Law Enforcement Training Council when they conduct misconduct investigations; ban the use of chokeholds unless deadly force is otherwise necessary to protect the life of the officer or someone else; require the Law Enforcement Training Council to establish statewide minimum policy standards for police departments and sheriff's offices on use of force, recruitment standards, body-worn cameras, and various other topics; establish a new division of the Law Enforcement Training Council tasked with ensuring agencies comply with the minimum policy standards.

HB 3623 | EARLY RELEASE OF AN INMATE

AFP Position: Support Result: Passed House: 62-45; In Senate Corrections and Penology Committee

Americans for Prosperity believes that proportional accountability and rehabilitation are equal goals of our justice system. Our system has failed at achieving both goals when it comes to addiction and substance abuse. This bill would provide the state parole board with greater flexibility to grant parole to certain individuals who have proven their rehabilitation and ensure that our justice system imposes more proportional punishment for individuals struggling with addiction.



HB 3037 | VEHICLE REGISTRATION, PRIVATE PASSENGER-CARRYING VEHICLE

AFP Position: Support Result: Passed House: 115-0; In Senate Transportation Committee

Law enforcement deserves better resources to help diagnose whether a citizen in need is suffering from a mental health emergency or is acting maliciously with intent. We can do more to ensure that fewer lethal incidents occur between law enforcement and communities on account of confusion or lack of proper training. This bill is a step in the right direction by ensuring that officers are more informed about the individuals they interact with on a daily basis. Equipping officers to know whether a driver suffers from a mental or physical health condition early in their interaction will equip them to be more prepared for situations that might quickly escalate or take an unexpected turn.

HB 3619 | CRIMINAL ASSET FORFEITURE

AFP Position: Support Result: In House Judiciary Committee; Awaiting SC Supreme Court Ruling on Civil Asset Forfeiture

Civil asset forfeiture turns the presumption of innocence, a cornerstone of the American justice system, on its head. And because the forfeiture process is a civil process, you have no right to an attorney. This bill would require the government to prove that the property was derived from criminal activity or allowed criminal activity to occur, while protecting property owners' due process rights.

BILL DESCRIPTIONS

SB 28 | DRIVER'S LICENSE: SUSPENDED DUE TO DUI


AFP Position: Support Result: Passed Senate 41-1; In House Judiciary Committee

Americans for Prosperity believes an effective criminal justice system protects people and preserves public safety, respects human dignity, restores victims, removes barriers to opportunity for people with criminal records, and ensures equal justice for all under the law. This bill will move us closer to achieving that vision by allowing those whose licenses have been suspended to opt into the Ignition Interlock Device Program, thus ensuring they can access the necessary transportation to maintain their employment and care for their families while also preserving public safety.

SB 150 | SOUTH CAROLINA COMPASSIONATE CARE ACT

AFP Position: Support Result: On Senate floor calendar

At Americans for Prosperity, we believe the proper role of criminal law is to protect public safety and order by punishing and deterring actions that harm people and property. This bill will establish a legal medical market for marijuana in South Carolina. By allowing innovation, industry, and research to thrive in a properly regulated medical marijuana market, South Carolina can ensure more individuals access the most transformative treatments and reduce the harms presented by a robust black market.



HB 3243 | LICENSURE

AFP Position: Support Result: Passed House: 98-5; In Senate Labor, Commerce, and Industry Committee

Between 1993 and 2012, South Carolina added 39 new occupational licenses within low and moderate income professions alone. Overall, approximately 18% of South Carolinians require a government license to earn a living in their professions. As burdensome as these occupational licenses are, the inability of some residents to even pursue occupational licenses makes it even harder for them to earn a living. This bill would allow people who are lawfully present in South Carolina and not precluded from establishing residency under federal immigration law, to be eligible for occupational or professional licensure.

SB 503 | PHYSICIAN ASSISTANTS AND ADVANCED PRACTICE REGISTERED NURSES

AFP Position: Support

Result: Passed House: 115-0; In Senate Transportation Committee

This bill empowers PAs and APRNS to order home health services to patients. This can be especially impactful in underserved communities that lack a reliable supply of physicians.

SB 290 | STATE HEALTH FACILITY LICENSURE ACT

AFP Position: Support Result: On Senate floor calendar

Governor Henry McMaster suspended burdensome government barriers called certificate-of-need laws to allow hospitals to swiftly add new services to care for patients with COVID-19. These emergency actions saved countless lives. This bill would empower hospitals and other facilities throughout the state to deliver new services, including emergency care, without going through the state's burdensome certificate-ofneed process, which requires health facilities to get government approval before expanding services. This would dramatically expand access to lifesaving care to patients in need.

SB 717 | CERTIFICATE OF NEED

AFP Position: Support Result: Passed Senate 46-0

Certificate of-need laws are state regulations that require health care providers to prove to a government CON board that building new facilities or expanding existing facilities meet their community's health care needs. This often results in incumbent health care providers exploiting CON boards to block or delay new health care providers from opening nearby and serving patients. This bill would exempt diabetes screening facilities from the state certificate-of-need and health facility licensure act.

BILL DESCRIPTIONS

SB 379 | PERINATAL CARE SERVICES

AFP Position: Support

Result: Passed Senate 43-0; In House Medical, Military, Public and Municipal Affairs Committee

This bill would direct the Department of Health and Environmental Control to promulgate rules to allow midwives to practice the full extent of their training. Empowering midwives with full practice authority is a crucial element of comprehensive health care reforms that will increase access, reduce costs, and improve outcomes for patients. This can be especially important in underserved communities that lack a reliable supply of physicians.

HB 3589 | SCHOOL OF CHOICE

AFP Position: Support Result: Signed by governor

The pandemic further demonstrated the need for families and students to access a broad range of options beyond their assigned traditional public school. This bill gives school districts the option to implement schools of innovation that provide more flexible ways to educate South Carolina students.

HB 3883 | EDUCATION: COMPETENCY-BASED **EDUCATION**

AFP Position: Support Result: Passed House: 108-4; In Senate Education Committee

Most schools in South Carolina are still designed for a world that no longer exists—a standardized model of

education that prepared students for a factory economy. To succeed in today's global economy, our students need different skills and mindsets that the factory model was not designed to foster. This bill would allow for this transition to a more personalized education experience, enabling more schools to focus on student-centered, innovative approaches.

HB 3575 | ALCOHOL

AFP Position: Support Result: Passed House: 99-14; On Senate Floor Calendar

COVID-19 has demonstrated that state regulations, including licensing or permitting restrictions on food and alcohol distribution, need to be updated to reflect consumer demand and economic opportunity. This bill offers an important lifeline to South Carolina's beer and wine retailers by enabling curbside service while incorporating logical restrictions and guidelines for health and safety.

HB 3772 | ALCOHOL

AFP Position: Support Result: Passed House: 84-27; In Senate Judiciary Committee

This bill would enable new, customer-driven changes in beer and wine sales to be made permanent. Regulatory relief adopted during the COVID-19 pandemic highlighted that many examples of red tape and burdensome permitting, licensing, and paperwork requirements were unnecessary. This bill throws a lifeline to South Carolina retailers, while continuing protections for public health and safety.



SB 506 | HOME-BASED FOOD PRODUCTS

AFP Position: Support Result: Passed Senate 40-0; In House Medical, Military, Public and Municipal Affairs Committee

COVID-19 has demonstrated the value of flexible work arrangements and home-based businesses, as well as the need to reduce regulations that stand in the way of innovation in South Carolina. This bill would provide certainty for home chefs, allowing them to provide for their families with clear, less burdensome rules.

HB 3354 | PROPERTY TAX, EXEMPTIONS

AFP Position: Oppose Result: Signed by governor

This bill would exempt renewable energy resource properties operating fewer than 20 kilowatts from property tax obligations. Americans for Prosperity supports a competitive energy market and opposes subsidies and mandates that pick some fuels or technologies over others. The government should not pick winners and losers, and virtually all government intervention in energy markets, whether in the form of taxes, mandates, tax credits, direct subsidies, or applied research and development, undermines consumer-driven signals and rewards politically connected firms or select industry segments.
