The votes referenced in the scorecard highlight the policy areas that were used to determine a legislator’s alignment with AFP-CO’s priorities.

Our grassroots lobbying activities, digital ads, mail, texting, phone calls, and more across the state centered around the following areas: 1) Taxes/Economic Opportunity: SB21-260; 2) Criminal


Justice Reform: HB21-1214; 3) Free Expression: HB21-1321; 4) Business: HB21-1027; 5) Education: HB21-1295; and 6) Health Care: SB21-175, HB21-1232.

Legislators were made aware of votes included in the scorecard through key vote alerts and activist engagement during the session.

AFP-CO would like to recognize the legislators who stood for freedom by sponsoring legislation, voting in committee, and voting on the floor of the legislature for policies that increase individual freedom and opportunity.

We hope that you will utilize this scorecard as a tool to hold lawmakers accountable for their performance and encourage them to continue to fight on your behalf to make Colorado the best place to work, live, and raise a family.

BILL DESCRIPTIONS

HB 1321 | VOTER TRANSPARENCY IN BALLOT MEASURES

Bill creates a false narrative of potential cuts if citizens decide they want to see a tax reduction.

Passed, signed into law

SB 260 | SUSTAINABILITY OF THE TRANSPORTATION SYSTEM

Bill would add an additional fee onto the price of gasoline with the goal of repairing Colorado’s existing transportation system and infrastructure. The legislation would add additional fees on diesel, deliveries and ride-share services, leading to wide-spread impact on families and businesses statewide during the economic recovery.

Passed, signed into law

SB 175 | PRESCRIPTION DRUG AFFORDABILITY REVIEW BOARD

Bill would create a government drug price “affordability” board and impose government price controls on life-saving therapies that apply to all health plans statewide. The result of this “reform” could easily lead to drug shortages, government rationing, fewer cures and therapies for patients, and the inevitable decline in health care access and quality.

Passed, signed into law

HB 1232 | STANDARDIZED HEALTH BENEFIT PLAN COLORADO OPTION

Bill attempted to create a public health insurance option that would have drastically increased health care costs for residents in the state, while simultaneously placing financial strains on hospitals. Despite being amended, this legislation adds more government intervention in our health care system and drives health care policy in the wrong direction.

Passed, signed into law

HB 1295 | REBUTTABLE PRESUMPTION IN CHARTER SCHOOL APPEALS

Bill would threaten the opening and operation of charter schools in the state, making it much more difficult for families to have access to educational options beyond their assigned school.

Died in committee

HB 1027 | CONTINUE ALCOHOL BEVERAGE TAKE OUT AND DELIVERY

Bill would extend the authorization of takeout and delivery of alcoholic beverages by authorized retailers. This legislation offers an important lifeline to Colorado’s retailers by enabling takeout and delivery while restaurants were unable to serve guests on the premises in a manner that protects public health and safety.

Passed, signed into law

HB 1214 | RECORD SEALING, COLLATERAL CONSEQUENCES REDUCTION

Bill would ensure that more Coloradans can achieve their full potential and secure a true second chance after paying their debt to our communities by expanding eligibility for individuals to petition a judge for record sealing. It would also provide automatic sealing of arrest records where prosecutors failed to bring formal criminal charges.

Passed, signed into law
