

Key Vote Alert: Vote YES on H.R. 1 One Big Beautiful Bill Act

Dear Member of Congress,

On behalf of millions of Americans for Prosperity activists in all 50 states, I urge you to support HR 1, The One Big Beautiful Bill Act, a critical step towards delivering meaningful economic relief to the American people and advancing the pro-growth policies championed by President Donald Trump.

Passing an extension and permanency for the Tax Cuts and Jobs Act out of the House is the first step in extending tax cuts for working Americans. The bill was an unmitigated success that benefitted American families, workers, and the overall economy. This landmark piece of legislation reduced individual income tax rates across-the-board, allowing Americans to keep more of their hard-earned money. It also slashed the corporate income tax rate, making American firms much more competitive internationally. In addition, TCJA also provided much needed incentives to work, save, and invest in the future.
